**DOC Bills**

HB 1052 An Act to allow the Executive Director of the Board of Pardons and Paroles to issue a warrant in the event of an escape from extended confinement.

Bill revises SDCL 24-15-14 and 24-15-21 for a warrant to be issued if an inmate on extended confinement escapes.

HB 1053 An Act to provide Earned Discharge Credits for inmates.

Bill would allow an inmate to receive earned discharge credits of up to 90 days for a program completion, completion of 360 hours of work (not to exceed 180 days in a 12 month period); up to 365 days for heroic acts in life threatening situations, through significant efforts in disaster response or providing assistance in maintaining safety and security in prison.

HB 1054 An Act to revise certain provisions regarding crimes that are considered violent for parole calculation purposes.

Bill adds aggravated criminal battery of an unborn child, aggravated battery of an infant, slinging by jail inmate and assault with intent to cause serious permanent disfigurement to list of violent crimes for purposes of parole eligibility calculations.

HB 1109 An Act to provide for parole eligibility for certain inmates.

Bill seeks to provide for parole consideration for seriously ill and aged inmates.

HB 1280 An Act to revise certain provisions regarding the calculation of suspended prison sentences.

Bill clarifies that the total sentence length for setting the sentence discharge date is the sum of imprisonment time and any suspended time or for a fully suspended sentence it is the term of imprisonment that has been suspended.

HB 1281 An Act to revise certain provisions regarding persons on probation and to declare an emergency.

Bill creates a self-executing provision that if a probationer is sentenced to DOC for a different case, the probation supervision is automatically terminated. The court that imposed the probation sentence could still revoke the probation and impose a prison sentence.

SB 161 An Act to revise provisions regarding assault committed against certain persons.

Bill would revise laws on simple assault and aggravated assault against law enforcement and DOC staff even if LE/DOC staff wasn't on duty.

### **Retirement/Personnel Laws**

SB 35 An Act to revise the classification of juvenile corrections agents in the South Dakota Retirement System and to revise certain terminology regarding correctional staff.

Bill adds JCA's to Class B retirement system; revises language of penitentiary correctional staff to correctional security staff.
