HB 1003 An Act to revise eligibility for a deferred imposition of sentence.

Bill removes the option for a deferred imposition of sentence if the offender is on parole at the time of a felony possession of a controlled substance or felony possession of a controlled substance by ingestion.

HB 1004 An Act to revise parole date calculation provisions.

Bill clarifies that an initial parole date is calculated on the incarceration term of a partly suspended sentence and makes it clear that all felony criminal history must be applied to the parole date calculation grid in SDCL 24-15A-32.

HB 1005 An Act to authorize a hearing panel of the Board of Pardons and Paroles to make clemency recommendations.

Bill would allow a panel of at least two members of the Board of Pardons and Paroles to conduct a clemency hearing, deny the application or recommend the application to the Governor.

HB 1006 An Act to revise the time requirements for parole reports and plans.

When an award of Inmate Earned Discharge Credits results in an initial parole date within 30 days, the bill directs the warden to submit the compliance report within seven days of the date of the application of the credits and the inmate submit their release plan upon completion.
