Offender Locator Frequently Asked Questions

What information is displayed?

Contains public information derived from court records provided to the Department of Corrections (DOC) and from Department of Corrections records. Conviction information on offenders who have discharged is not included.

Who is being displayed?

Contains public information on felony offenders sentenced to the South Dakota Department of Corrections. Information includes South Dakota offenders sentenced to prison. Inmates from other states incarcerated in South Dakota prisons and offenders sentenced to county jail, probation, or any other form of supervision are not included. Offenders supervised under the Interstate Parole Compact agreements in South Dakota or from South Dakota are included.

How current is the information?

Information is updated nightly from the prior day for security reasons. Information provided is from the current conviction(s) and is current as of last discharge.

Demographics are updated in accordance with DOC policy. Information includes last known demographics for the offender. Demographics of offenders who discharge are not updated.

Current Facility ? Virtual Facility (SD Offender elsewhere)

Current facility for the inmate selected. Offenders who display a facility of "Virtual Facility (SD Offender elsewhere)" are South Dakota inmates housed in another state or jurisdiction.

Additional Info ? NA

Displays Attempt to Locate (ATL), Absconder or Escape status of Offender. **ATL** are issued to law enforcement when offenders on parole supervision whereabouts are unknown and efforts are underway to determine if offender has absconded. **Absconders** indicate offenders on parole supervision whose whereabouts are unknown. **Escape** statuses are displayed depending on the type of escape from prison.

Parole Office ? Sioux Falls Field Office

Current parole office for offender selected. Offenders who display an office of "Community VP (ISC out of State)" are South Dakota offenders on parole supervision in another state.

Discharged ? 08/01/2011

A date in the **Discharged** field indicates the date the offender is no longer on supervision with the South Dakota Department of Corrections. Offenders with "NA" indicate offenders under supervision with the Department of Corrections.

Booking Key Dates

Summary of dates from all convictions.

Initial Parole Date

Earliest release date to parole supervision.

Next Review Date

Date of next Board of Pardon and Parole hearing.

Suspended Sentence Release Date

Date of completion of the term of imprisonment and only applies to inmates with suspended sentences.

Term Expires Date

Date the term is completed. This represents end of term of parole or if not on parole, end of sentence and release from prison.
