## II Policy:

The Department of Corrections (DOC) will use the LSI-R assessment to help determine an inmate's programming needs and to prioritize programming based on the inmate's overall need.

## **III Definitions:**

#### LSI-R:

Level of Service Inventory-Revised. An assessment used to measure an inmate's risk to reoffend and to define the inmate's programming needs.

#### LSI Core:

Programs required and/or recommended as a result of the LSI-R assessment; i.e. Thinking for a Change (T4C), Moral Recognition Therapy (MRT).

## **Custody Classification Risk:**

The risk levels of Maximum, High Medium, Low Medium and Minimum are used to predict an inmate's risk of institutional escape and violence (See DOC policies 1.4.B.2 *Male Inmate Classification* and 1.4.B.14 *Female Inmate Classification*).

## **Community Risk:**

A level of risk established by the Community Risk assessment which is used to predict the risk of an individual parolee's supervision failure (See DOC policy 1.5.G.4 *Parole Services-Community Risk Assessment and Supervision of Offenders*).

### P-Scan:

An assessment used to rate the inmate's tendency toward psychopathic behaviors.

#### **New Admission:**

A person sentenced to serve time with the DOC who is admitted to a DOC facility for the first time under that sentence; including new commitments, suspended imposition of sentence (SIS) and suspended execution of sentence (SES) admissions, Federal Bureau of Prison admissions, and Federal Probation and Parole admissions. This definition specifically excludes parole/suspended sentence violators, U.S. Marshal Holds, "detainees" and "extended detainees".

## Parole/Suspended Sentence Violator (PV/SSV):

An offender under supervision who is transferred from the supervision of a parole agent to a DOC facility following a violation of the offender's supervision agreement.

#### Detainee:

An offender whose supervision is transferred by a parole agent to a DOC facility for a period not to exceed five (5) working days (120 hours), excluding weekends and holidays. Within the five (5) working days (120 hours) detainment period, the parolee must either be released, be designated as a parole violator or self-commit to the Community Transition Program (CTP). The detainment can be extended an additional five (5) working days (120 hours) by authorization of a parole supervisor. The Executive Director of the Board of Pardons and Paroles must authorize a detention beyond the additional five (5) working days (120 hours) detention.

**Extended Detainee:** An extension to a detainer, authorized by the Executive Director of Parole Services, which is issued for a variety of reasons, such as investigative purposes, waiting for a placement opening, a disciplinary sanction to a violation of the supervision agreement, etc. (See ARSD § 17:61:01:01 (4) and 17:61:01:11). The detainment extension may be for up to ninety (90) calendar days.

#### U.S. Marshal Hold:

An inmate placed in a DOC facility under contract by the U.S. Marshals until arrangements are made to transfer the inmate to federal custody.

## **Motivational Interviewing:**

A direct counseling style for eliciting behavior change by helping inmates to explore and develop ambivalence toward their criminal behavior, which in turn motivates the inmate to address and resolve factors contributing to criminal behavior.

## Scheduled Programs:

Academic (GED, Basic Ed and Literacy), Chemical Dependency Treatment, Sex Offender Treatment, Vocational Education, Thinking for a Change and Moral Recognition Therapy.

## **IV Procedures:**

## 1. LSI-R Assessment

- A. The main objective of the LSI-R assessment is to reduce recidivism by identifying and targeting an inmate's specific criminogenic needs through programming and the use of motivational interviewing.
- B. Admission case managers will complete LSI-R assessments on all new admissions, parole violators, and suspended sentence violators admitted from the community. (A new LSI-R is not completed on suspended sentence violators who have their suspended sentence imposed prior to release to the community.
- C. If unit staff believes an inmate's LSI-R assessment is inaccurate, staff will consult with the Risk Reduction Manager to determine if another LSI-R assessment should be administered.
- LSI-R assessments will be conducted in conjunction with trailer assessments administered by Behavioral Health staff and Education staff.

E. Admissions Case managers will interview each inmate using the LSI-R interview guide and motivational interviewing.

- F. Case managers will make referrals for additional assessment work to Behavioral Health and/or Education staff based on the results of the LSI-R and trailer assessments.
- G. In addition to sources identified within this policy, case managers may use other available sources to confirm information scored on the assessment.

## 2. LSI-R Interview Scoring Guide:

- A. LSI-R assessment subgroup 1 CRIMINAL HISTORY:
  - 1. The case manager will develop a criminal history profile based on current and past offenses. Sources: Criminal History sheet in the legal file.
    - a. Past offenses include all felony and misdemeanor convictions received as an adult or juvenile.
      - 1) A search of the Comprehensive Offender Management System (COMS) will be completed for all inmates to verify the existence of any juvenile history.
    - b. Juvenile history starts with the earliest arrest or adjudication of the juvenile.
    - c. The items referencing previous adult convictions and number of prior adult convictions are cumulative; i.e. the same inmate can be scored on items 2.a., 2.b. and 2.c. (below).
  - 2. The following items will be scored after the interview. The case manager will gather the following information:
    - a. Any previous adult convictions (Score if "yes").
    - b. Number of prior adult convictions > 2 (Score if two or more).
    - Number of prior adult convictions > 3 (Score if three or more).
    - d. Number of current offenses/transactions on this admission  $\geq 3$  (Score if three or more).
    - e. Juvenile arrest under the age of sixteen (Score if "yes").
    - f. Incarcerated upon conviction (This item will always be scored "yes").
    - g. Any escape or attempted escape history from a court ordered facility/placement. (Score if "yes".) DO NOT SCORE ABSCONDING FROM PAROLE/PROBATION OR FLEEING FROM ARREST/ELUDING POLICE.
    - h. Disciplinary record while in prison (Score if the inmate was ever found to have committed a major Offense in Custody and a sanction was imposed).
    - i. Probation or parole violations where a sanction was imposed by the supervising agent. A revocation is not necessary to score this information. Sources: COMS, parole violation reports, probation violation reports, technical violations and inmate self-report (Score if violations are present) (See DOC policy 1.5.G.6 Response to Violations).

j. Incidence of violence – This item includes <u>any</u> act of violence. A felony conviction is not required. Sources: COMS, public school records, DOC juvenile system information, institutional disciplinary, inmate self-report, NCIC, criminal history database, PSI, parole and jail reports (Score if violence is present).

- Information about any victim(s) will be gathered; i.e. age, gender, relationship to the inmate.
- B. LSI-R assessment subgroup 2 EDUCATION AND EMPLOYMENT HISTORY.
  - 1. The case manager will develop an educational and employment profile based on the inmate's work history and educational involvement.
  - 2. The following will be scored for the employment profile:
    - a. Current employment status Is the inmate unemployed? If the inmate is serving a short sentence i.e. 60 days or less and states he/she will still be employed upon release-attempt to verify this information. Do not score if it can be <u>verified</u> the inmate is serving a short sentence and will still be employed when he/she gets out of prison. If the inmate has been incarcerated for more than two (2) years, employment history while incarcerated is scored.
    - b. Frequency of unemployment in the past two (2) years.
      - 1) Score if the inmate is employed less than fifty percent (50%) of the time in the last two (2) years or has held three (3) or more jobs in the last twelve (12) months or if primary employment was from temporary day labor agencies.
      - 2) Do not score if the inmate is attending school full-time.
      - 3) If incarcerated for more than two (2) years, score incarceration time. If incarcerated less than two (2) years, score twelve (12) months prior to incarceration.
    - c. Has the inmate ever held a job for a full year (Score if "no").
    - d. Was the inmate ever fired from a job (Score if "yes").
  - The following will be scored for the education profile (items a and b are cumulative):
    - a. The highest grade of school completed was < grade 10 (Score if "yes").
    - b. The highest grade of school completed was < grade 12 (Score if "yes").
    - c. Was the inmate ever suspended or expelled from any school due to disciplinary/ delinquent behavior? (Score if "yes" but do not score if the inmate was suspended due to poor academic performance).
  - 4. The following will be scored based on performance in work/school:
    - a. Determine the inmate's attitude and orientation about work/school performance (Score if poor attitude and performance is present).
    - b. Determine the inmate's relationship with co-workers/other students (Score if poor or no relationship exists).
    - c. Determine the inmate's relationship with boss/teachers (Score if poor or hostile relationship exists).

5. Information on an offender's work skills will be gathered.

### C. LSI-R assessment subgroup 3 – FINANCIAL STATUS.

- 1. The case manager will develop a financial profile of the inmate to identify the inmate's ability to handle his/her finances.
- 2. Review the inmate's current financial situation.
  - a. If the inmate has had unstable employment, as indicated in the previous subgroup, and has had difficulty paying bills or accumulated large debt (Score if the inmate is concerned about how he/she will meet obligations or use best judgment if the debt(s) appears overwhelming and the inmate has no plans to pay off the debt). Additionally, score this item if the inmate is identified as having a gambling problem.
  - b. Determine if the inmate relies on social assistance/welfare (Score if the inmate relies on social economic assistance programs).
  - c. Information on court ordered obligations; i.e. restitution, fines, fees, child support, etc. will be gathered.

## D. LSI-R assessment subgroup 4 – FAMILY/MARITAL.

- 1. The case manager will develop a profile of the inmate based on current and past family and marital relationships.
- 2. Determine if the inmate is happy with his/her current marital situation or equivalent (Score if the inmate is dissatisfied with his/her current situation).
- Determine if the inmate has a non-rewarding parental relationship (Score if non-rewarding parents are present in the inmate's life and have an impact on his/her behavior). Score if both parents are deceased or one parent is deceased and the other parental relationship is nonrewarding.
- 4. Determine if the inmate has non-rewarding relatives, other than his/her parents (Score if non-rewarding other relatives are present in the inmate's life and have an impact on the inmate's behavior).
- 5. Determine if the relatives or spouse/equivalent has current or prior criminal behavior (Score if a parent, sibling or spouse/equivalent has a criminal record).

## E. LSI-R assessment subgroup 5 – ACCOMMODATION.

- 1. The case manager will develop a profile of the inmate based on current accommodations.
- 2. If the inmate is within five (5) years of his/her scheduled parole date, determine the inmate's living plans upon release to parole (Score if the plan is unsatisfactory; i.e. CTP, halfway house, high crime neighborhood).
- 3. Determine the number of address changes the inmate had in the past year prior to incarceration (Score is based on twelve (12) months prior to incarceration, if incarcerated less than two (2) years. If incarcerated greater than two (2) years, scare is based on last twelve (12) months of incarceration). Score if > 3.

4. Determine if the inmate lives in a high crime neighborhood (This item will always score yes).

### F. LSI-R assessment subgroup 6 – LEISURE/RECREATION

- 1. The case manager will develop a profile of the inmate based on how leisure time is used.
- 2. Determine if the inmate has participated in any formal organized activity on a regular basis with a pro-social group of people (Score if the inmate did not participate).
- 3. Determine if the inmate makes good use of his/her spare time (Score if the inmate's use of time contributes to problems; i.e. drinking, drug use, gambling).

## G. LSI-R assessment subgroup 7 - COMPANIONS.

- 1. The case manager will develop a profile of the inmate based on who he/she spends time with. This does not include family and spouse, as these were previously scored.
- Determine if the inmate is a social isolate, if they experience difficulty meeting others and/or
  have limited social skills. The inmate may present as shy or demonstrate a chronic inability to
  form bonds or interact with someone as a friend/companion (Score if the inmate has no social
  relationships with anyone other than a relative).
- 3. Determine if companions the inmate spends significant time with are criminal influences. (This item must always be scored if currently incarcerated).
- 4. Determine if the inmate has any companions that engage in criminal behavior or have criminal records (Score if "yes").
- 5. Determine how many pro-social companions the inmate knows. (The inmate must have at least two (2) pro-social companions in order not to score this item).
- 6. Determine how many pro-social companions the inmate knows. The inmate needs at least two (2) companions that have never been in trouble and are an active part of the inmate's life. The inmate must not engage in anti-social behavior while with the pro-social companion(s) (Score "yes" if <2 pro-social friends).

#### H. LSI-R assessment subgroup 8 – ALCOHOL/DRUG PROBLEMS.

- 1. The case manager will develop an alcohol/drug profile based upon the inmate's use of alcohol and/or drugs and affects upon his/her life.
- 2. Determine if the inmate has ever had an alcohol problem (Score based on presence of negative impact on life multiple arrests, work problems, health problems, financial problems, etc.).
- 3. Determine if the inmate has ever had a drug problem (Score based on the same criteria as the alcohol problem).
- 4. Determine if the inmate currently has an alcohol problem (Score if the alcohol problem affects more than one life area).
- 5. Determine if the inmate currently has a drug problem (Score if the drug problem affects more than one life area).

6. Determine if the inmate's drug or alcohol problems have contributed or may contribute to law and/or supervision violations (Score if "yes"). Do not score for drug possession or involvement in drug transactions that are purely for financial gain).

- 7. Determine if alcohol/drug use has contributed to family/marital problems (Score if "yes").
- 8. Determine if alcohol/drug use has contributed to school/work problems (Score if "yes").
- 9. Determine if alcohol/drug use has contributed to medical problems. Medical problems include injuries sustained due to be intoxicated, hepatitis, sleep loss, memory loss, weight loss, suicide attempts or other health related items contributed to alcohol/drug use. (Score if "yes").
- Determine if the inmate has other behavioral proof of a drug or alcohol problem; i.e. difficulty cutting back on usage, sneaking drinks or fixes, blackouts, IV drug use. (Score if other indicators of an alcohol/drug problem exist).
- I. LSI-R assessment subgroup 9 EMOTIONAL/PERSONAL.
  - The case manager will develop an emotional/personal profile based on the inmate's overall mental health.
  - 2. Determine if the inmate is having any moderate psychological issues that interfere with social functioning; i.e. mild anxiety, insomnia, or mild depression (Score if the interviewer feels moderate psychological issues are present).
  - 3. Determine if the inmate is having severe psychological issues such as: excessive sweating, delusional thinking, rambling conversations, odd or strange verbalizations, extreme passivity or aggression, verbal abusiveness or hallucinations (Score if these behaviors are present).
  - 4. Determine if the inmate has had mental health treatment in the past. This includes substance abuse treatment or counseling sessions with social workers or school counselors (Score if the inmate was seen by a counselor and treatment was received).
  - 5. Determine if the inmate is currently receiving mental health treatment/services or has received treatment/services in the past year.
  - 6. Determine if the inmate has undergone a mental health evaluation or assessment within the last year and problems or behavior disorders were indicated, or the inmate has a diagnosed mental health disorders (Score if "yes").
- J. LSI-R assessment subgroup 10 ATTITUDE/ORIENTATION.
  - 1. The case manager will develop an overall profile of the inmate's attitude and orientation relative to his/her current situation.
  - 2. Determine if the inmate's attitude is supportive of crime, such as the inmate placing a value on criminal behavior or minimizing his/her participation in committing a crime (Score if the inmate fits this profile).
  - 3. Determine if the inmate's attitude is unfavorable toward non-crime alternatives, such as the inmate working and going to school, but still using drugs, engaging in violent behavior, etc. (Score if the inmate fits this profile).

4. Determine if the inmate's attitude is unfavorable toward his/her sentence (Score if the inmate deems his/her sentence to be "unfair", or places blame on others for his/her sentence, i.e. the judge or an attorney).

5. Determine if the inmate's attitude is unfavorable toward his/her classification or placement (Score if the inmate objects to his/her classification and/or placement).

## 3. Risk/Needs Levels Based on the LSI-R Score:

- A. Inmate LSI-R Risk/Needs levels are determined by the following scores:
  - 1. **High Risk/Needs** score of 40 or higher on the LSI-R assessment.
  - 2. Moderate High Risk/Needs score of 33-39 on the LSI-R assessment.
  - 3. Moderate Risk/Needs score of 26-32 on the LSI-R assessment.
  - 4. Low Moderate Risk/Needs score of 19-25 on the LSI-R assessment.
  - 5. Low Risk/Needs score of 0- 18 on the LSI-R assessment.

## 4. High Risk Response:

- A. An inmate with an LSI-R score of =>40 for females or =>37 for males will have a P-Scan completed by the Admissions Case Manager upon completion of the LSI-R, or prior to a staff member making a referral to the Risk Reduction Manager.
  - Male inmates scoring 37+ on the LSI-R will have a PSCAN completed by Admissions Case Managers prior to being transferred out of the Admissions Unit. Female inmates scoring High Risk/needs may not be placed in minimum custody placement during the 90-day observation period or prior to receiving a P-Scan.
- B. An inmate who scores =>30 on the P-Scan will be referred to a clinical psychologist for further comprehensive psychological review.
  - 1. Inmates who score => 30 on the P-Scan will not be placed in a minimum custody placement prior to a psychological review.
  - 2. Inmates referred to a psychological review that refuse to participate in the evaluation will sign a program refusal form and will have a non-compliance rating on their IPD.
- C. Inmates who have been identified as Level 2 or Level 3 System Risk in accordance with DOC policy 1.4.G.6 *System Risk Classification* will not be placed in minimum custody placement.

## 5. Assessments Used in Case Planning:

- A. INTAKE PROCEDURE Inmates will undergo the following assessments to determine program needs, facility placement, housing placement and supervision level.
  - 1. CD ASSESSMENT:
    - a. Deferred diagnosis: 2.

## 2. MENTAL HEALTH ASSESSMENT:

- a. No restrictions: NR.
- b. Periodic access Mental Health staff available five (5) days a week: PA.
- c. Special needs: SN.
- d. Twenty-four (24) hour a day mental health access required. HA
- e. Periodic access: Severe Mental Illness: PA SMI.
- f. Special needs: Severe Mental Illness: **SN SMI**.
- g. All inmates will receive a level of functioning assessment at the time of intake.

#### 3. EDUCATION ASSESSMENT:

- a. GED needed: Y/N.
- b. GED and Literacy needed: Y/N.

## 4. MEDICAL ASSESSMENT:

- a. No restrictions: NR.
- b. Periodic access: medical services are provided daily: PA.
- c. Twenty-four (24) hour access to medical services: HA.
- d. Handicapped facility required: HC.
- e. Medical services are provided weekly: OA.

## 5. STOP:

- Sexual behavior issue present recommended for treatment: Coded as a 2 with a Y on recommendations.
- Sexual behavior issue present not recommended for treatment: Coded as a 2, with a N on recommendations.
- c. No sexual behavior Issues no sex offender assessment required: Coded as a  ${\bf 1}$  with a  ${\bf N}$  on recommendations.

- a. Identified as a potential sexual aggressor: AP institutional code.
- b. Identified as a potential sexual victim: **VP**.
- c. Identified as a potential sexual aggressor in the community: **AP** community code.
- No score on the PREA assessment: NS.
- e. Mixed: MX.

### 7. AIMS ASSESSMENT: (Males only)

- a. AIMS A Aggressive personality characteristics leaders.
- b. AIMS **B** Aggressive personality characteristics.
- c. AIMS **C** Normal aggressive/passive personality characteristics.
- d. AIMS **D** Passive personality characteristics followers.
- e. AIMS **E** Extremely passive personality characteristics followers.

#### 8. CUSTODY CLASSIFICATION:

- a. Maximum custody: **MX**.
- b. High medium custody: HM.
- c. Low medium custody: **LM**.
- d. Minimum custody: MN.

#### 9. COMMUNITY RISK:

- a. Intensive supervision: INT.
- b. Maximum supervision: **MAX**.
- c. Medium supervision: MED.
- d. Minimum supervision: MIN.

### 10. LSI-R ASSESSMENT:

- a. High risk/needs: H.
- b. High moderate risk/needs: **HM**.
- c. Moderate risk needs: M.
- d. Low moderate risk/needs: LM.

- e. Low risk/needs: L.
- 11. System Risk Classification:
  - a. Level 3 High
  - b. Level 2 Moderate-high
  - c. Level 1 Low-moderate
  - d. Level 0 Low
- B. Following each listed assessment are the programming options or system response service access requirements that are possible assessment outcomes.

## 6. LSI-R Case Planning:

- A. When a course/program is required based on an assessment recommendation within the context of an inmate's individual program directive (IPD), compliance will be determined in accordance with DOC policy 1.4.B.1 *Individual Program Directives (IPD)*.
  - A course/program is "required" within the context of IPD and centralized scheduling procedures.
  - 2. An inmate who is "required" to participate in a program but is not scheduled to participate will not be considered non-compliant with that element of his/her IPD.
  - 3. If an inmate is "required" to participate in a program and is placed in that program, his/her refusal to participate adequately will result in a non-compliant rating.
- B. CRIMINAL HISTORY (subgroup):
  - 1. If the criminal history score is = or > 6: Thinking for a Change is required.
  - 2. If the inmate has a conviction for a violent crime in the past two (2) years: anger/stress management is recommended.

### C. EDUCATION/EMPLOYMENT:

- 1. Refer for a Test of Adult Basic Education (TABE) if the inmate is identified through LSI-R assessment as not having a GED or high school diploma.
- If the inmate is referred for the TABE test, use recommendations of the educational staff for required programming.
  - a. GED/Literacy.
  - b. GED.
- 3. Offenders who meet any of the following criteria will be recommended for employability programming.
  - a. Offender had three (3) or more jobs in the last twelve (12) months in the community.

b. Fired from a job in the last twelve (12) months in the community.

- c. Held only temporary jobs in the last two (2) years.
- d. Self-employed but did not maintain steady work.

#### D. FINANCIAL:

- 1. Credit where Credit is Due is recommended if the inmate scores on the financial section of the LSI-R. This item is scored if the offender meets one (1) of the following criteria:
  - a. Significant obligations for his/her IFR amounts over \$10,000 total- child support, court costs, fines, restitution, etc.
  - b. The inmate was assessed with a gambling problem.
  - c. The inmate has considered or declared bankruptcy in the last two (2) years, or admits financial struggles.

#### E. FAMILY/MARITAL:

- 1. Parenting classes are recommended if the inmate has a family/marital score ≥ 2 and has custody of children under age eighteen (18) with whom he/she is planning to reunite with, or the inmate is planning on having children. For females inmates— the inmate may be approved to participate in the Parents and Children Together (PACT) program.
- 2. Domestic violence prevention is recommended for female inmates who are a victim of domestic violence in the last five (5) years.
- 3. Domestic violence programming is recommended for male inmates who have a history of domestic violence on record in last five (5) years.

#### F. ACCOMMODATION:

- Release planning to a halfway house or Community Transition Program (CTP) is recommended if the accommodation score is ≥ 2 and the inmate plans on paroling to a high crime neighborhood.
- 2. The transition case manager will be notified if the inmate plans to release to CTP.

### G. LEISURE/RECREATION:

- 1. If the inmate scores ≥1, counsel the inmate on activities available; i.e. recreational opportunities, religious activities, inmate organizations.
- 2. There is not programming available to the inmate for this subgroup but it will be included as a "sub-factor" in case planning.

## H. COMPANIONS:

1. If the companions score is ≥2, counsel the inmate on companion activities available to him/her; i.e. M-2/W-2.

2. There is not programming available to the inmate for this subgroup but it will be included as a "sub-factor" in case planning.

#### I. ALCOHOL/DRUG:

- 1. Each inmate will receive a CD assessment upon admission.
- 2. The CD assessment recommendation will be used for program determination.

#### J. EMOTIONAL/PERSONAL:

- 1. If the inmate is scored on either item 46 or 47, he/she will be referred to Mental Health for a consultation.
- 2. The referral will include all information self disclosed by the inmate during the LSI-R interview that prompted the Case Manager to score that item.

#### K. OVERALL LSI-R SCORE:

1. If the inmate scores ≥ 33 on the LSI-R assessment, MRT will be required program and will be added to their IPD Individual Program Directive.

## 7. Programming:

- A. Attendance rosters will be developed based on inmates' overall need for the following:
  - 1. Chemical dependency.
  - 2. Academic.
  - 3. Cognitive Programming.
  - 4. Employment.
