Values:

The core beliefs that guide the DOC's thinking and decision making.

Vision Statement:

A brief, general statement that describes the organizational direction and focus.

IV. PROCEDURES

1. Overview:

A. Mission Statement:

Support service with purpose in a culture of respect through integrity, humility, and character.

B. Vision:

Safer South Dakota communities for the next generation.

C. Values:

We value our staff as our greatest asset.

We value a safe environment for staff and offenders.

We value community support and collaboration.
